

## LS 508: Petitioning - Designated Areas

(Any location changes must be approved by Regional Manager)

Austin Davis Branch Library	On the sidewalk between the library front entrance doors and the book returns. The petition table and activities must be 10 feet away from the entrance.
Arthenia L. Joyner University Area Community Library	Southwest corner of the library by the flag pole but off of the sidewalk.
Bloomington Regional Library	On the sidewalk to the left of the main entrance as you face the building.
Brandon Regional Library	Under the east overhang to the right of the main entrance, midway between the ADA access door and the book drops.
Charles J. Fendig Branch Library	Southwest corner of the building near the bike rack and off the sidewalk.
C. Blythe Andrews Library	Southwest corner of the library on 26th Street, just north of the parking lot and sidewalk leading to the library entrance. The area is approximately 13ft x 9ft.
Egypt Lake Partnership Library	Not applicable - Hillsborough County School District property
Jan Kaminis Platt Regional Library	Front of the library, but off to the side, so they are not directly at the entrance. Do not block the walkway as customers are approaching the building; stay off to the side.
Jimmie B. Keel Regional Library	Sidewalk to the left of front doors. Must be at least 12 feet from the door in order to not block handicap ramp; must not block bench or bicycle rack.
John F. Germany Library	East end of the Ashley Street entry sidewalk (intersection of entry sidewalk and public sidewalk). The area is to be no more than 10 feet from the public sidewalk, and no more than 6 feet from the north wall of the entry sidewalk (ledge).
Lutz Branch Library	Public sidewalk running in front of library to the south of the main library entrance in front of the train sculpture. Must not block access to entrance steps.
Maureen B. Gauzza Library	Left sidewalk while entering the library building. The petition table and activities must be 10 feet away from the library exit door.
New Tampa Regional Library	Outer sidewalk to the left side of the pass-through column, 20 feet from the front doors.

North Tampa Branch	Sidewalk that runs along the front of the library to the south of the entrance plaza.
Port Tampa City Library	On the sidewalk immediately in front of the library, but not directly in front of the door.
Riverview Branch Library	South side of the building to the right of the main entry doors on the sidewalk between the handicapped ramp and the east exit from the Community Room.
Robert W. Saunders, Sr. Library	Sidewalk 10 feet south of the main entrance. Must not block off the drop off area.
Ruskin Branch Library	Public sidewalk on Dickman Drive, not blocking the front steps or the handicap ramp.
Seffner-Mango Branch Library	Left side of the sidewalk coming into the library. The petition table should be 10 feet away from the entrance.
Seminole Heights Branch Library	Sidewalk south of the east entrance. The area is to be 10 feet from the entrance and must not block the sidewalk from the parking lot nor block the book drop or bicycle rack.
78th Street Community Library	On the sidewalk to the right of the main entrance as you are facing the building.
SouthShore Regional Library	North half of the patio outside the Regional Manager's Office (not to block access to the outdoor bench or the bicycle rack)
Sulphur Springs Partnership Library	Not applicable - Hillsborough County School District property
Thonotosassa Branch Library	50 feet away from the entrance on the right side of the library.
Town 'N Country Regional Library	Either side of the parking lot entrance between the building posts/columns. The entrance to the building must remain clear at all times.
West Tampa Branch	Public sidewalk on Union Street, east of the gated entrance to the library.
